DOCUMENTS REQUIRED

1. Photocopy of NRIC (front & back)
2. **Proof of Income** (Salaried Person) : Latest computerised payslip **AND** Income Tax Notice of Assessment **OR** CPF Statement for the past 6 months (Self-Employed) : Latest Income Tax Notice of Assessment for the past 2 years
3. **Latest CDP Statement (if shares are pledged as collateral)**
4. Any other documents as may be requested by the Bank at its sole discretion
